RE: Municipal Regulation of Adult Entertainment

I. Introduction.

Tower Center at Unity Square (hereinafter "Unity Square") is a public park owned by the City of Bartlesville, Oklahoma (hereinafter the "City"). Since its completion in July of 2020, Unity Square has been operated by the Bartlesville Community Center Trust Authority (hereinafter the "BCCTA") pursuant to a Memorandum of Understanding dated May 22, 2018¹ and a Lease and Operating Agreement dated April 1, 2019.²

September 10, 2022, Oklahomans for On Equality (hereinafter "OKEQ") hosted their annual "Bartlesville Pride" event at Unity Square pursuant to a Green Space Rental & Agreement dated September 6, 2022 (the "Rental Agreement").3 2022 "Bartlesville Pride" event was September 10, advertised widely by OKEQ as "family friendly" and the event was attended by a number of families including minor children.4 The September 10, 2022 "Bartlesville Pride" event included a drag queen show. 5 The September 10, 2022 event was the source

of significant controversy, including an organized protest, and was attended by numerous concerned citizens who believe that the drag queen show included sexualized content which was inappropriate for minor children. Following the event, local resident, Shannon King, initiated a petition on change.org which received over 2,000 signatures (hereinafter the "Petition"). The Petition asks the City to "[p]rohibit adult oriented entertainment in public spaces." The Petition was presented to the Bartlesville City Council by Mrs. King at its October 3, 2022 regular meeting along with public comment from numerous residents both for and against the Petition.⁶

II. Issue.

In her public comments on October 3, 2022, Mrs. King stated the issue as follows:

I ask you to determine if this activity violated any state laws, city ordinances, or city contracts for use of public areas and if so, to take appropriate action. If no laws or ordinances were broken, and no current contracts violated, then I ask you to study this issue and consider new city ordinances to prohibit adult-oriented activity from happening in public areas again.⁷

Based on Mrs. King's statement of the issues raised by her Petition, and the author's understanding of the task assigned to him by the City Council, this memorandum will address the following issues:

- A. What sexual activity is prohibited by state and local statutes and ordinances?
- B. What contractual standards are applicable to adult oriented programming in Unity Square?
- C. What actions can and cannot be taken by the City Council to prohibit adult oriented entertainment in public spaces?

This Memorandum is being provided as legal advice to the Bartlesville City Council and is intended to be relied upon by them only. It is not the purpose of this Memorandum, nor the role of the City Attorney, to express his own policy preference or to make any policy recommendations.

III. Discussion.

A. What sexual activity is prohibited by state statutes and local ordinances?

1. Municipal Criminal Ordinance.

The City's existing ordinances prohibit certain sexual activity in public. Those ordinances are as follows.

Bartlesville Municipal Code § 12-64 defines "Lewd" as "licentious, lecherous, dissolute, debauched, impure, salacious or pornographic." Section 12-64 prohibits indecent exposure as follows:

Every person who willfully either lewdly exposes his person, or private parts thereof, in any public place, or in any place where there are present other person to be offended or annoyed thereby, or procures, counsels, or assists any person to lewdly expose himself to public view, or to the view of any number of person such as is offensive to decency, or is adapted to excite vicious or lewd thoughts or acts, shall be guilty of an offense against the City of Bartlesville, Oklahoma. *Id*.

Bartlesville Municipal Code § 12-65 goes on to prohibit lewd conduct as follows:

Every Person who conducts himself in a lewd manner, or in any manner suggestive of lewdness, shall be guilty of an offense against the City of Bartlesville.

The City's prohibition on disturbance of the Peace is found in Bartlesville Municipal Code §§ 12-91 through 12-94. Section 12-94(a) provides, in pertinent part, that: "[i]t is unlawful for any person to willfully or maliciously disturb, either by day or night, the peace and quiet of the city, family or person by... obscene or profane language, whether addressed to the parties so disturbed or so some other person.

The City has specifically adopted state law relating to misdemeanors. Bartlesville Municipal Code § 12-191 provides: "[t]he City of Bartlesville hereby adopts all misdemeanor offenses now contained or hereafter contained in Title 21 of Oklahoma Statues. The City has no jurisdiction over felony offenses, which must be prosecuted by State, Tribal or Federal prosecutors with jurisdiction over crimes committed in Washington County. To the knowledge of the author, no

citations were issued by the Bartlesville Police Department or other law enforcement agencies, and no charges have been filed in the Bartlesville Municipal Court for violation of these or other ordinances stemming from actions which took place in Unity Square on September 10, 2022.

2. State Criminal Statutes.

Likewise, existing State statutes already prohibit certain sexual activities in public. Those statutes are as follows.

Title 21, Section 22 of the Oklahoma Statutes provides:

Every person who willfully and wrongfully commits any act which grossly injures the person or property of another, or which grossly disturbs the public peace or health, or which openly outrages public decency, including but not limited to urination in a public place, and is injurious to public morals, although no punishment is expressly prescribed therefor by this code, is guilty of a misdemeanor. *Id*.

Title 21, Section 1021(A) of the Oklahoma Statues prohibits Indecent exposure in pertinent part as follows:

Every person who willfully and knowingly either:

- 1. Lewdly exposes his or her person or genitals in a public place...;
- 2. Procures, counsels, or assists any person to expose such person, or to make any other exhibition of such person to public view or to the view of any number of person, for the purpose of sexual stimulation of the viewer;

Shall be guilty, upon conviction, of a felony... Id.

Finally, Title 21, Section 1123 of the Oklahoma Statutes provides, in pertinent part:

- A. It is a felony for any person to knowingly and intentionally:
 - 5. In a lewd and lascivious manner and for the purpose of sexual gratification:

- c. cause, expose, force or require a child to look upon the body or private parts of another person,
- d. force or require any child under sixteen (16) years of age or other individual the person believes to be a child under sixteen (16) years of age, to view any obscene materials, child pornography or materials deemed harmful to minors as such terms are defined by Sections 1024.1 and 1040.75 of this title,
- e. cause, expose, force or require a child to look upon sexual acts performed in the presence of the child, or
- f. force or require a child to touch or feel the body or private parts of the child or another person. *Id*.

To the knowledge of the author, no citations were issued by the Bartlesville Police Department or other law enforcement agencies, and no charges have been filed in Washington County District Court or other appropriate venue for violation of these or other statutes stemming from actions which took place in Unity Square on September 10, 2022.

3. Municipal Licensing Requirements.

It does not appear that the drag queen performers at Unity Square on September 10th are residents of Bartlesville. While the author was not present at the event, review of numerous video recordings of the event disclosed that tipping of the performers was pervasive. It is unknown to the author whether OKEQ paid the performers for their services, however, it is clear that all performers received tips throughout their respective performances. As such, it would appear that cash consideration is a significant motivation for this type of performance.

Sexually Oriented Businesses are regulated under Bartlesville Municipal Code § 5-120. Section 5-120 defines a Sexually Oriented Business, in pertinent part, as a "business where live performances or recorded media in any form... for any consideration to patrons for use in or viewing of... specified sexual activity." Section 5-120 goes on to defines Specified Sexual Activity as:

(1) The fondling or other erotic touching of human genitals, pubic area, buttocks, anus, vulva or breasts;

- (2) Sex acts, normal or perverted, actual or simulated, including, but not limited to, intercourse, oral copulation, masturbation or anal copulation;
- (3) Excretory functions as part of or in connection with any of the activities set forth in subsection (18)(a) or (b) of this section; or
- (4) Physical violence, bondage, mutilation, or rape, actual or simulated, as part of or as related to, any of the activities set forth in subsections (18)(a), (b), or (c) of this section.

As currently defined, the drag performances at Unity Square do not appear to qualify as Sexually Oriented Businesses under the Bartlesville Municipal Code. Thus, even though it is apparent that the drag queens were performing for monetary gain, their performances were not Specified Sexual Activity, so they were not engaged in a Sexually Oriented Business as defined by our Code.

Bartlesville Municipal Code § 5-181 outlines the requirements for licensing of Temporary Businesses. Specifically excluded from Bartlesville's Temporary Business licensing requirements are "activities involving the expression of First Amendment speech." 8 Issues involving protected speech are discussed at length hereinafter.

B. What contractual standards are applicable to adult oriented programming in Unity Square?

Pursuant to the Lease and Operating Agreement dated April 1, 2019, the BCCTA has sole authority to operate Unity Square subject to certain requirement of the City. Among those requirements is the following:

- (d) No Discrimination.
- (i) The BCC shall not exclude any individual, group or organization from participation in, deny the benefits of, or otherwise tolerate unlawful discrimination on the basis of race, creed, color, national origin, sex, age, physical handicap or sexual orientation, in the use of Tower Center in any contracts relating to Tower Center, in any programs carried out on the premises of Tower Center, in the employment of any individuals who may provide services or work at Tower Center, or in the selection of vendors, suppliers, service providers, students, teachers, sponsors or others

in matters relating to the use or operation of Tower Center.9

Consistent with this requirement, the BCCTA did not deny OKEQ's application to reserve Unity Square for its event based on sexual orientation or other protected classification.

The BCCTA and OKEQ entered into the Rental Agreement on or about September 6, 2022. The final paragraph of the Rental Agreement provides as follows:

signing this agreement, I acknowledge the compliance requirements of the Bartlesville Community Center Practices and Procedures Information; and Rental Fee Schedule, and agree to adhere to all guidelines, rules, practices and procedures as stated therein, as well as all local, state and federal laws. Failure on the part of the LESSEE to comply with the terms of this agreement may result in the immediate cancellation and may influence decisions regarding future use of the I acknowledge that my requirements equipment, services, rental times may change prior to the event and I will be billed for actual cost for the above referenced items and services. If any of the equipment you have requested will be unavailable for your event, you will be notified.

The document referred to in the Rental Agreement as the Bartlesville Community Center Practices and Procedures Information¹⁰ provides as follows:

Performance Content As this is a public space and open to citizens of all ages, the Lessee is responsible to ensure that movies, videos, music, and productions at Unity Square are appropriate for the audience attending the event as set out in the Motion Picture Association of America (MPAA) film rating system and local community standards. Lessee must also notify the Box Office if an event will have content which may not be appropriate for certain age groups as patrons must be advised at the Box Office at the time of ticket purchase. At the sole discretion of the Unity Square Management Committee, it may require the work to be redacted or canceled if it determines that the work violates local community standards of decency and finds that

the work, taken as a whole: appeals to the prurient interest; depicts or describes, in a patently offensive way, sexual conduct specifically defined by the applicable state law; and lacks serious literary, artistic, political or scientific value. 11

Additionally, the Bartlesville Community Center Practices and Procedures Information provides as follows:

Conduct Lessee is responsible for the conduct of all event guests, vendors, representatives, performers, volunteers, and participants during the signed contract time at Unity Square. Lessee is responsible for making certain that all persons involved are familiar with BCC/Unity Square policies. 12

OKEQ was provided with a copy of the Bartlesville Community Center Practices and Procedures Information when it entered into the Rental Agreement with the BCCTA. At no time did OKEQ "notify the Box Office if an event will have content which may not be appropriate for certain age groups" as required by the Rental Agreement. The Rental Agreement provides that "[f]ailure on the part of the LESSEE to comply with the terms of this agreement may result in immediate cancellation and may influence decisions regarding future use of the BCC."

C. What actions can and cannot be taken by the City Council to prohibit adult oriented entertainment in public spaces?

1. Police Powers:

American constitutional jurisprudence recognizes the inherent authority of a state and its political subdivisions, such as municipalities, to establish laws and ordinances which regulate health, welfare, and morality in pursuit of the common good and public welfare. This authority, called "police powers" stems from British common law, and is protected by the 10th Amendment to the United States Constitution which provides that "[t]he powers not delegated to the United States by the Constitution, nor prohibited by it to the States are reserved to the States respectively, or to the people." A municipality's police power to regulate health, welfare and morality is not unlimited, however, and is specifically

restricted by the First Amendment to the United States Constitution.

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances. 14

Though it is well established that under its inherent police powers a municipality may regulate sexual expression as hereinafter discussed, "[t]he portrayal of sex, e.g., in art, literature and scientific works, is not itself sufficient reason to deny material the constitutional protection of freedom of speech and press." 15

The City of Bartlesville has already exercised its inherent police power to regulate sexually oriented businesses within the corporate limits of the City of Bartlesville through zoning as outlined in Bartlesville Municipal Code, Appendix A \S 7.7.3.16

2. Forum Analysis:

Any analysis of the implication of a given regulation on First Amendment freedom of speech must begin with a forum analysis. A forum analysis is required because the Supreme Court has recognized that nothing in the Constitution requires the Government freely to grant access to all who wish to exercise their right to free speech on every type of Government property without regard to the nature of the property or to the disruption that might be caused by the speaker's activities. A municipality, as an owner of real property, "has power to preserve the property under its control for the use to which it is lawfully dedicated. Is Nonetheless, since the 1939 case of Schneider v. New Jersey the Court has confirmed the right of the people to communicate in public forums.

In Cornelius v. NAACP the Supreme Court confirmed its forum analysis test "as a means of determining when the

Government's interest in limiting the use of its property to its intended purpose outweighs the interest of those wishing to use the property for other purposes."20

[T] he extent to which the Government can control access depends on the nature of the relevant forum. Because a principal purpose of traditional public fora is the free exchange of ideas, speakers can be excluded from a public forum only when exclusion is necessary to serve a compelling state interest and the exclusion is narrowly drawn to that interest. Similarly, when Government has intentionally designated a place or means of communication as a public forum speakers excluded without be a compelling governmental interest. Access to a nonpublic forum, however, can be restricted as long as restrictions are reasonable and [are] not an effort suppress expression merely because public officials oppose the speaker's view.21

The Court went on to explain in Perry Educ. Ass'n v. Perry Local Educators' Ass'n:

In places which by long tradition or by government fiat have been devoted to assembly and debate, the rights of the state to limit expressive activity are sharply circumscribed. At one end of the spectrum are streets and parks have immemorially been held in trust for the use of the public, and, time out of mind, have been used for purposes of assembly, communicating thoughts between citizens, and discussing public questions. these quintessential public forums, government may not prohibit all communicative activity. For the state to enforce a content-based exclusion it must show that its regulation is necessary to serve a compelling state interest and that it is narrowly drawn to achieve that end. The state may also enforce regulations of the time, place, and manner of expression which are contentnarrowly tailored to neutral. are serve significant government interest, and leave open ample alternative channels of communication. 22

This forum analysis is evident in every meeting of the Bartlesville City Council. In the agenda item traditionally listed as "Citizens to be Heard", the Bartlesville City Council has created a limited public forum in which it limits commenters to persons to sign the register and announce their name and residential address, and further limits their comments to three minutes. In this limited public forum, the City Council has the authority to further restrict what is said, by limiting comments to items which are on the agenda, for instance, or eliminating comments entirely. In this case, it is clear that Unity Square, a public park, is a traditional or quintessential public forum which the rights of the government to limit expressive activity are circumscribed. Any regulation of expressive activity at Unity Square or other public places in Bartlesville must be (a) necessary to serve a compelling government interest and (b) narrowly tailored to achieve that legitimate end. This test is often referred to as "Strict Scrutiny".

3. Reasonable Time Place Manner Restrictions:

In $Cox\ v$. New $Hampshire^{23}$, the Supreme Court recognized a government's authority to regulate the time, place, and manner of communication in public places. Finally, in $Grayned\ v$. $City\ of\ Rockford$, the Court identified a principle of compatible use to decide time, place, and manner conflicts: "The crucial question is whether the manner of expression is basically incompatible with the normal activity of a particular place at a particular time." 24

Time, place and manner limitations on expressive activity are considered to be content neutral, and thus are subject to intermediate scrutiny and frequently upheld. To survive First Amendment constitutional challenges, such restrictions must satisfy a three-prong test outlined by the Supreme Court in Ward v. Rock Against Racism.

- 1. The regulation must be content neutral.
- 2. It must be narrowly tailored to serve a significant governmental interest.
- 3. It must leave open ample alternative channels for communicating the speaker's message.²⁵

Absent a categorical or substantial ban on a traditional method of expressive activity, courts routinely uphold time, place, and manner restrictions as satisfying the requirement of narrow tailoring.

4. The Intractable Obscenity Problem²⁶:

Content-based laws are presumptively unconstitutional and subject to strict scrutiny, the highest form of judicial review, whereas content-neutral laws generally must survive only intermediate scrutiny.

A law that is content based on its face is subject to strict scrutiny regardless of the government's benign motive, content-neutral justification, or lack of 'animus toward the ideas contained' in the regulated speech.²⁷

The exception to this hard and fast rule appears to be regulation which prohibits obscene content.²⁸

In the seminal case of *Miller v. California*²⁹, the Supreme Court attempted to reconcile its prior inconclusive pronouncements by establishing a test for obscenity. The Miller court announced its decision as follows:

This much has been categorically settled by the Court, that obscene material is unprotected by the Amendment. The First and Fourteenth Amendments have never been treated as absolutes. We acknowledge, however, the inherent dangers of undertaking to regulate any form of expression. State statutes designed to regulate obscene materials must be carefully limited. As a result, we now confine the permissible scope of such regulation to works which depict or describe sexual conduct. That conduct must be specifically defined the applicable state law, as written or authoritatively construed. A state offense must also be limited to works which, taken as a whole, appeal to the prurient interest in sex, which portray sexual conduct in a patently offensive way, and which, taken as a whole, do not have serious literary, artistic, political, or scientific value.30

The *Miller* Court further explained that the basic guidelines for the trier of fact must be:

(a) whether `the average person, contemporary community standards' would find that the work, taken as a whole, appeals to the prurient interest, (b) whether the work depicts describes, in a patently offensive way, sexual conduct specifically defined by the applicable state law; and (c) whether the work, taken as a whole, lacks serious literary, artistic, political, or scientific value.31

Since Miller, the accepted test for the constitutionality of a given restriction on obscene speech is:

- Does the speech appeal to the prurient interest?
- Does the speech depict or describe, in a patently offensive way, sexual conduct defined by applicable state law?
- Does the speech lack serious literary, artistic, political or scientific value?

If that answer to all three of these questions is yes, then the speech is obscene and may be restricted under the *Miller* precedent.

5. Obscenity Must Be Erotic:

The Supreme Court has indicated that in order for a State to prohibit expression as obscene, the expression must be erotic. In Cohen v. California, the Supreme Court considered the constitutionality of the State's citation of Robert Paul Cohen for the crime of disturbing the peace for wearing a jacket emblazoned with the phrase "Fuck the Draft" in a California Courthouse.³² The Cohen Court concluded that Mr. Cohen's jacket did not incite a breach of the peace because the statement was not directed at any particular recipient.³³ The Cohen Court also ruled that the statement in question was not obscene.

Whatever else may be necessary to give rise to the States' broader power to prohibit obscene

expression, such expression must be, in some significant way erotic. It cannot plausibly be maintained that this vulgar allusion to the Selective Service System would conjure up such psychic stimulation in anyone likely to be confronted with Cohen's crudely defaced jacket.³⁴

Under *Cohen*, any ordinance adopted seeking to prohibit obscenity in public spaces would likely need to be limited to erotic acts. Proponents of the drag queen show in Unity Square deny that the show on September 10th was erotic. The Petitioners disagree, arguing that the show is a sexualized display through the performance of actual or simulated sexual acts.

6. Community Standards:

In establishing its test for obscenity, the *Miller* Court acknowledged that diverse people, and the communities that they represent, will undoubtedly have different views and attitudes about what is and what is not obscene.

It is neither realistic nor constitutionally sound to read the First Amendment as requiring that the people of Maine or Mississippi accept public depiction of conduct found tolerable in Las Vegas, or New York City. People in different States vary in their tastes and attitudes, and this diversity is not to be strangled by the absolutism of imposed uniformity.³⁵

After offering this rationale, the Miller Court went on to outline the "constitutionally adequate" standard by which a trial court should evaluate the materials with reference to community standards of a municipality in which an obscenity ordinance is being challenged on First Amendment grounds.

[T]he primary concern with requiring a jury to apply the standard of 'the average person, applying contemporary community standards' is to be certain that, so far as material is not aimed at a deviant group, it will be judged by its impact on an average person, rather than a particularly susceptible or sensitive person—or indeed a totally insensitive one.³⁶

The City Attorney has received a number of inquiries from City Councilmen and members of the general public, both informally and through Open Records Requests, asking what Bartlesville's Community Standards are. The City Bartlesville has not adopted any written "community standards" and Community Standards are not legally defined. Rather, Community Standards are determined by a trier of fact in a lawsuit (i.e., Judge or Jury) based on evidence presented in a trial. Certainly, the City has in its possession certain materials relating to codes of conduct, rules for use of public facilities, ordinances, and other documents which could be viewed by a tier of fact as indicative of the Community Standards for decency in Bartlesville, Oklahoma. unlikely however, that the documents in the possession of the City would alone be determinative of what the Community Standards of Bartlesville, Oklahoma are. To illustrate, in 2003 Larry Peterman, the proprietor of an adult bookstore in Provo, Utah was acquitted on 15 counts of misdemeanor obscenity in part because it was proven at trial that the residents of Provo, Utah were disproportionately large pornography.³⁷ As such, Provo's residents' consumers of pornographic propensities was deemed by the jury to be a more relevant metric of the communities standard than any written material stored at City Hall.

In an effort to answer the Council's questions regarding Community Standards, and to comply with the City's obligations under the Oklahoma Open Records Act (hereinafter the "OORA"), the City Attorney has reviewed all documents which are in the possession of the City which, in the view of the City Attorney, may be relevant to a determination of what Bartlesville's Community Standards are. Because those records are voluminous, they have not been included with this Memorandum. Those records will be made available to the members of the City Council and OORA requestors contemporaneous with the delivery of this Memorandum. To be clear, these documents are not intended to represent a comprehensive list of all documents which be relevant to a determination of Community Standards, only those which are in the possession and control of the City of Bartlesville.

IV. Conclusion.

The City of Bartlesville may, under its inherent police power, enact reasonable restrictions upon adult entertainment so long as those restrictions are (1) content neutral, (2) narrowly tailored to serve a significant government interest, and (3) leave open ample alternative channels for alternative communication. City ordinances and state statutes regulating this area are already on the books. The City may also restrict adult entertainment which is deemed obscene. Those restrictions, and any new restrictions enacted by the Bartlesville City Council will be evaluated using the Miller test based on prevailing Community Standards in Bartlesville as determined by a judge or jury based on the evidence presented to them at trial.

Consider and take action on Lease and Operating Agreement between the City of Bartlesville and the Bartlesville Community Center Trust Authority for the management, maintenance, and operation of the Tower Center at Unity Square.

II. STAFF COMMENTS AND ANALYSIS

Prior to beginning design of the public improvement project now known as the Tower Center at Unity Square, a Memorandum of Understanding (MOU) was approved by the City of Bartlesville (City), the Bartlesville Community Center (BCC), and the Price Tower Arts Center (PTAC). This MOU acknowledged the collaboration between the three parties concerning the management, maintenance and operation of the Tower Center facility once construction was completed. Included in this MOU were roles and responsibilities of each party as we believed them to be at that time as well as the formation and membership of a management committee to oversee the management, maintenance, and operation of the facility once constructed. The importance of this document was to help guide the design process with intention given to ensure that the facility, as constructed, could be maintained as expected. The document also provided for its amendment as needed. A copy of this MOU is attached.

With design substantially complete and construction near at hand, formalizing the process by which the Tower Center facility will be managed, maintained, and operated is necessary. Attached for Council consideration is a draft Lease and Operating Agreement between the City and the BCC Trust Authority which would lease the Tower Center at Unity Square facility to the BCC Trust Authority upon completion of construction. The purpose of the trust indenture for the BCC Trust Authority is "to develop, redevelop, restore, and beautify the central regions of the... City of Bartlesville, by providing cultural and educational facilities and activities which will benefit and strengthen the culture and economy of the (City)." While not specifically stated in the Trust Indenture, this is what grants the BCCTA its authority over the Community Center property. The sole beneficiary of this trust is the City of Bartlesville.

It is this broad purpose that would allow the City Council to lease the Tower Center at Unity Square property and facility to the Community Center Trust Authority.

The attached draft agreement has been reviewed and approved by Val Callaghan, Managing Director for the BCC, and Will Haskell, Trust Authority Chair.

III. RECOMMENDED ACTION

The Council is requested, at its April 1 regular meeting, to consider and take action on a Lease and Operating Agreement with the Bartlesville Community Center Trust Authority for the management, maintenance, and operation of the Tower Center at Unity Square. Staff recommends approval of the Lease and Operating Agreement at attached hereto.

MEMORANDUM OF UNDERSTANDING

- This Memorandum of Understanding (MOU) is entered into by and between the Price Tower Arts Center (PTAC), the Bartlesville Community Center (BCC), and the City of Bartlesville (City).
- A. <u>Purpose</u>. This MOU sets for the collaborative relationship between the three parties as stated above concerning the management, maintenance, and operation of the Tower Green (Facility), a city-owned facility located at 6th and Dewey.
- B. Roles and Responsibilities. The roles and responsibilities concerning the management, maintenance, and operation of the Tower Green are assigned to each party as follows:
 - 1. The PTAC agrees to
 - a. Provide programming of the space for visual arts;
 - b. Provide catering services of food and drink as requested for the Facility;
 - c. Together with the BCC, keep the Facility in a clean and safe condition and to provide day-to-day maintenance of the Facility, to include but not limited to mowing, edging, weed control, fertilization, and care and maintenance of all amenities (benches, water features, structures, art work, etc.) within the Facility.
 - 2. The BCC agrees to
 - a. Provide programming of the space for the performing arts;
 - b. Serve as the general point of contact for any party wishing to reserve the space;
 - c. Be responsible for the collection of all revenues arising from the use of the Facility and to report these monthly to the Management Committee;
 - d. Together with the PTAC, keep the Facility in a clean and safe condition and to provide day-to-day maintenance of the Facility, to include but not limited to mowing, edging, weed control, fertilization, and care and maintenance of all amenities (benches, water features, structures, art work, etc.) within the Facility.
 - 3. The City agrees to
 - a. Provide solid waste, water, and sanitary sewer services;
 - b. Pay for general electrical use for the space (does not include electrical use at the performance stage).
- C. <u>Management Committee</u>. There is hereby formed a management committee which will oversee the management, maintenance, and operation of the Tower Green. Said management committee shall consist of the following members:
 - 1. A representative of the Bartlesville City Council
 - 2. A representative of the Price Tower Arts Center Board of Trustees
 - 3. A representative of the Bartlesville Community Center Trust Authority
 - 4. A representative of the Bartlesville Regional Chamber of Commerce Board of Directors
 - 5. A representative of the Bartlesville Convention and Visitors Bureau Board of Directors
- **D.** <u>Amendment.</u> This MOU will be revised after the design and/or construction of the Facility is completed as is necessary to ensure the proper long-term management, maintenance, and operation of the Facility.

LEASE AND OPERATING AGREEMENT

This Agreement is made and entered into as of _____ day of _____, 2019, by and between the City of Bartlesville, Oklahoma, a Oklahoma municipal corporation, (the "City"), and the Bartlesville Community Center Trust Authority, a public trust, (the "BCC"), for the management, maintenance, and operation of the Tower Center at Unity Square ("Tower Center") located between the Bartlesville Community Center and the Price Tower in downtown Bartlesville.

Background

- A. On March 4, 2018 Bartlesville voters approved General Obligation Bond Proposition #2 which included funding for a downtown gathering space to be known as Tower Center at Unity Square ("Tower Center").
- B. Construction of Tower Center is ongoing.
- C. The City is interested in increasing access to art and cultural activities for the community and wants to facilitate the operation of the Tower Center for the benefit of the citizens of Bartlesville.
- D. The BCC is experienced in programing performing and visual art activities and other cultural events which improve the quality of life in the community.
- E. The parties have agreed that upon completion of Tower Center, BCC will market, manage, program, and operate Tower Center for the benefit of the Bartlesville Community subject to the requirements hereinafter set forth.
- F. It is the intent of the City that the BCC share these responsibilities with the Price Tower Arts Center as may be further defined and agreed to by the parties and Price Tower Arts Center.

The parties agree as follows:

- 1. Term. Upon completion of Tower Center, a Final Site Plan will be completed and incorporated in this document as Appendix A for the purpose of describing the "Leased Premises." The Initial Lease Term of the lease of Tower Center shall be one (1) year, which shall commence on the first of the month following the date on which a Certificate of Use and Occupancy has been issued for Tower Center, subject to the requirements of Section 13 below.
- 2. Lease Renewal. This lease shall renew automatically upon the expiration of its term unless either party provides written notice to the other party of its intent not to renew the Lease at least thirty (30) days prior to expiration of the then current lease term.

3. Permitted Use; Operational Standards.

(a) General. After completion of construction and upon commencement of the lease term, the BCC shall be solely responsible for the full cost of any alterations,

improvements or additions to the Tower Center. The BCC must secure the permission of the City before performing any repairs, maintenance or improvements to the real estate or buildings of Tower Center which exceed \$25,000. For any such projects, the City will assist the BCC in contracting the work to the BCC's specifications. The BCC shall at all times comply in all material respects with all existing and future laws, rules and regulations applicable to or affecting the BCC, and its operations in Tower Center.

- (b) Fees, Charges, and Donations. The BCC will determine the eligibility of individuals, families and organizations for participation in programs at Tower Center; provided that, the BCC will ensure that its programs conducted at Tower Center are accessible to members of the community during all normal hours of operation. The BCC may impose activity fees and charges for participation in programs and activities conducted by the BCC at Tower Center. The activity fees must be priced in accordance with fees and charges typical of similar organizations in similar communities and must be consistent with the BCC's stated goals of permitting participation by individuals, families and organizations form the surrounding area. All revenues paid for use of Tower Center or donations received for Tower Center operations shall be paid to and belong to the BCC and shall be restricted for operating costs of the Tower Center. All donations received for capital improvements to Tower Center shall be paid to and belong to the City and shall be restricted for capital improvement of Tower Center.
- (c) Concessions. The BCC may grant licenses for limited portions of Tower Center to concessionaires of the BCC's choosing and otherwise subcontract limited operational functions to subcontractors of the BCC's choosing. The BCC is responsible for compliance by all concessionaires with all applicable local, state, and federals laws. Further the BCC is responsible for all actions and activities of any subcontractors with regard to Tower Center and shall bear sole responsibility for making all payments to any such subcontractors.

(d) No Discrimination.

- (i) The BCC shall not exclude any individual, group or organization from participation in, deny the benefits of, or otherwise tolerate unlawful discrimination on the basis of race, creed, color, national origin, sex, age, physical handicap or sexual orientation, in the use of Tower Center in any contracts relating to Tower Center, in any programs carried out on the premises of Tower Center, in the employment of any individuals who may provide services or work at Tower Center, or in the selection of vendors, suppliers, service providers, students, teachers, sponsors or others in matters relating to the use or operation of Tower Center.
- (ii) The BCC will require compliance with the provisions of this section by any person (including any subcontractor that provides goods, services or other items) who uses or accesses Tower Center. The BCC shall not be responsible for noncompliance with this section by any person other than the BCC.

- (iii) As between BCC members and non-members, the BCC shall furnish its accommodations and/or services on a fair, equal, and not unjustly discriminatory basis to all users thereof, and it shall charge fair, reasonable, and not unjustly discriminatory prices for each service. The BCC may make available reasonable and nondiscriminatory discounts, rebates or other similar types of price reductions. Noncompliance with this section shall constitute a material breach of this Agreement. In the event of such noncompliance, the City shall have the right to judicially enforce such provision.
- (e) Personnel. The BCC shall employ all Tower Center personnel and shall be responsible for hiring, training, promoting and discharging personnel, and for all other matters relating to personnel and staffing, including paying salaries, wages, payroll taxes, unemployment benefits and any other form of compensation or benefit to any personnel at Tower Center. The BCC's employees, agents and personnel are not employees of the City. The BCC may enter into arrangements with others relating to loaned or leased employees, but, notwithstanding the foregoing, the BCC is responsible for the conduct, behavior, appearance and attitude of all personnel at Tower Center at all times. The BCC will establish and adhere to written standards and criteria applicable to all employees, staff and service personnel of Tower Center. The employee standards and criteria will require, among other things, civil conduct, good behavior, well-kept appearance, positive attitude and helpfulness to patrons at all times.
- (f) Complaints. The BCC will consider and handle any complaints of employees, families, guests or others who use or receive any of the services or resources of Tower Center. The BCC will establish and adhere to procedures for receiving and processing complaints in an orderly and timely manner. Upon request by the City, and subject to any privacy and confidentiality obligations imposed by law, the BCC will advise the City of actions taken on a specific complaint involving Tower Center operations.
- (g) Safety. The BCC will post rules governing the conduct and behavior of any person who uses or accesses Tower Center. The BCC will hire trained and competent personnel necessary to enforce the rules of conduct. The BCC will develop and adhere to a written plan governing comprehensive safety of Tower Center. The safety plan will establish emergency procedures with regard to natural disaster, acts of violence and perceived or actual threats of violence. The BCC also will establish general safety requirements relating to security, lighting, and other appropriate safety matters.

4. Maintenance.

(a) Costs and Expenses. The BCC will pay all costs and expenses of operating Tower Center, with exceptions provided herein, and will maintain the park facility and improvements to Tower Center. The BCC shall comply with all applicable federal, state and local laws, rules, regulations, and specifications relating to the Tower Center park facility. Also, the BCC shall keep and maintain all equipment,

- furnishings, appliances and other personal property in good operating condition and in accordance with applicable manufacturer's specifications.
- (b) Repairs. The BCC will make all repairs necessary to keep Tower Center in good condition and from deteriorating in value or condition, ordinary wear and tear excepted. The BCC will commence repairs with regard to any and all aspects of Tower Center as quickly as reasonably possible, but in no event later than 60 days from the date that the need for such repairs is discovered and reported to the BCC. Such repairs will be made in expeditious and workmanlike manner. In the event that the BCC does not undertake such repairs within the time provided, or if the City determines that an emergency requires repairs to be performed immediately, the City may, after two days' written notice to the BCC, undertake to make such repairs as it may deem necessary for and on behalf of the BCC, and in such event, the BCC shall reimburse the City for the cost of such repairs upon request.
- (c) Exterior and Structural. BCC will maintain the pavilion, landscaping and parking areas and other areas of Tower Center in a good state of appearance and at BCC's expense.
- (d) Cleanliness and Sanitation. The BCC shall keep Tower Center, tidy, orderly and in good order and condition at all times and shall arrange for or oversee the prompt collection and proper disposal of trash, garbage, litter and debris.
- (e) Landscaping. BCC will maintain all landscaping at Tower Center in neat and tidy condition, and will undertake, supervise or oversee appropriate watering, fertilizing, weed removal and lawn maintenance.
- (f) *Utilities*. The City shall provide solid waste, water and sanitary sewer services to Tower Center free of charge to the BCC. The City shall pay for general electric use at Tower Center, provided, however, that the BCC shall make application for, obtain, pay for, and be solely responsible for all utilities required, used, or consumed at the performance stage, including, but not limited to, gas, water, telephone, electricity, and cable television.
- (g) No Waste. The BCC shall neither commit nor allow to be committed any waste at Tower Center, nor shall the BCC maintain, commit or permit the maintenance or commission of any nuisance at Tower Center or use Tower Center for any unlawful purpose.
- (h) Reserve Funds. The BCC shall maintain reserve funds sufficient in the BCC's reasonable judgment to meet the BCC's maintenance obligations under this Agreement.
- 5. Insurance. The parties shall maintain insurance with regard to Tower Center pursuant to the following terms:
 - (a) General Liability Insurance. The BCC shall maintain premises liability insurance at

the BCC's expense throughout the Initial Lease Term and any renewal insuring the City and the BCC against liability for injury to or death of any person occasioned by or arising out of the management, occupancy and operation of the Tower Center, providing not less than a \$125,000 per occurrence coverage limit and a \$1,000,000 aggregate coverage limit. The policy of insurance shall provide that the insurer must notify the City at least 30 days before cancellation or termination of the policy. Said amounts shall be increased annually as the City's exposure under the Oklahoma Governmental Tort Claims Act increases. The City shall not be required to maintain general liability insurance but agrees that it will be liable for its own negligence and willful misconduct and that of its officers, employees and authorized agents in accordance with the Oklahoma Governmental Tort Claims Act. The City and the BCC acknowledge that insurance policies do not always cover all events that create liability for an insured.

- (b) Property and Casualty Insurance. The City shall maintain property and casualty insurance with annual reimbursement by the BCC throughout the Initial Lease Term and any renewal a policy of fire, extended coverage, vandalism, malicious mischief and burglary insurance covering damage to Tower Center in the full amount of the replacement cost of Tower Center (excluding land and the footings and foundations) with deductible amounts reasonably determined by City. The insurance policy required to be maintained pursuant to this section shall name the City as the loss payee. Except as set forth below, any proceeds from said insurance shall be paid by City to the BCC to pay the cost of repairs relating to the insurance payment, except in the case of Complete Loss (see subparagraph (e) below). Said insurance shall provide a deductible consistent with deductibles under policies usually and customarily carried for similar buildings. Deductibles shall be the responsibility of the BCC.
- (c) Evidence of Insurance. The City shall furnish evidence to the BCC of insurance required by this section.
- (d) Waiver of Subrogation. All policies covering real or personal property that either party obtains affecting the Leased Premises shall include a clause or endorsement denying the insurer any rights of subrogation or recovery against the other party. The BCC and the City waive any rights of subrogation or recovery against the other for damage or loss to their respective property due to hazards covered, or that should be covered, or that are typically covered by policies of insurance obtained by either party, or that should be or have been obtained pursuant to this Lease, to the extent of the injury or loss covered by such insurance. For purposes of the preceding sentence, any deductible shall be deemed to be insurance coverage.
- (e) Complete Loss. If Tower Center is substantially damaged or destroyed by fire or any other casualty, the City shall, at its option, within 180 days from the date of the damage or destruction, begin to repair, reconstruct, or replace the damaged or destroyed building or improvement and pursue the repair, reconstruction, or replacement with reasonable diligence so as to restore the building to substantially the condition it was in before the casualty, or

- 6. Fiscal Management. The BCC may charge the public a fee for the use of Tower Center consistent with the policy of the BCC. Fees charged to users will be determined based upon the amount of revenues which the BCC needs to maintain its overall operations. In all cases, fees charged to users of Tower Center will be fair and reasonable. The financial activities of the Tower Center shall be kept separate from the financial activities of the BCC. Additionally, the financial records of the Tower Center shall be presented in a separate column in the BCC annual audited financial statements, so that the assets, liabilities, net assets, revenues, expenses, and other activities of the Tower Center can be easily viewed separate from those of the BCC. This information may be presented as supplementary information, a combining schedule, a note to the financial statements, or in any other manner that meets the minimum requirements of this section and generally accepted accounting principles. Upon request by the City, the BCC will provide reasonable access to the financial records of Tower Center, including books, records, software, work papers, financial statements and other supporting documentation
- 7. Management Committee. The BCC shall create a committee for the purpose of overseeing its obligations under this Agreement. Such committee shall consist of the following members:
 - (a) Two (2) representatives designated by the Bartlesville City Council;
 - (b) A representative designated by the Price Tower Arts Center Board of Trustees;
 - (c) A representative designated by the Bartlesville Community Center Trust Authority;
 - (d) A representative designated by the Bartlesville Convention and Visitors Bureau Board of Directors; and
 - (e) Three (3) at-large representatives designated by the five (5) aforementioned representatives of the management committee.
- 8. Taxes. The BCC shall timely pay any and all taxes, assessments, license fees, excises, and charges of every sort, nature, and kind ("Tax") that are levied, assessed, charged, or imposed upon or against Tower Center during the term of this Agreement. If the BCC considers the imposition of any Tax to be improper, illegal, or excessive, the BCC may dispute and contest the Tax. In such event and to the extent permitted by law, the BCC will not be required to pay the Tax until it is determined to be valid. The BCC must first notify the City of any Tax dispute. The City shall cooperate with the BCC at the BCC's expense in any Tax contest.
 - 9. BCC Representations. The BCC represents and warrants to the City that:
 - (a) this Agreement and all other documents referenced herein have been duly authorized and, upon execution and delivery, will constitute legal, valid and binding obligations of the BCC, *enforceable* against the BCC in accordance with the terms thereof;
 - (b) with regard to Tower Center, the BCC is in full compliance with all applicable environmental laws, rules, requirements, order, directives, ordinances and regulations, and the BCC is not aware of any potential claim or liability under any such environmental laws, rules, requirements, orders, directives, ordinances and regulations or of any events, conditions, circumstances, activities, practices, actions or plans which may give rise to any such claim or liability.

- 10. Additional Facility Use. The BCC will advise, consult and cooperate with the City and the Price Tower Arts Center to make Tower Center available from time to time to the City and the Price Tower Arts Center for city and Price Tower functions, community events and City or Price Tower sponsored activities. The City will not pay any fees associated with these occasional uses. It is the intent of the parties that the BCC share responsibility for visual arts programming at Tower Center with the Price Tower Arts Center.
- 11. Indemnification. Each party will indemnify and hold harmless the other party and its agents, officers and employees from and against any and all liabilities, losses, damages, costs and expenses (including attorney's fees, alternative dispute resolution expenses and other fees and expenses), causes of action, suits, claims, demands and judgments of any nature arising out of or in connection with any aspect of Tower Center operation or any activity that occurs in Tower Center Property, except to the extent directly caused by the negligence or willful misconduct of the either party or its agents, officers or employees acting in their official capacity as such (and not as patrons of Tower Center) to the extent provided by the law.
- 12. Events of Default. Except as otherwise set forth in this Agreement, this Agreement may be terminated only upon the occurrence of an Event of Default. It shall be an Event of Default if:
 - (a) the BCC fails, through no fault of the City, to satisfy in any material respect its obligations under this Agreement, and the failure continues for 30 days after written notice by the City;
 - (b) the BCC experiences an event or materially violates an agreement with a third party, which event or violation, in the City's reasonable judgment, will materially change the BCC's ability to perform its obligations under this Agreement;
 - (c) the BCC is subject to any action, voluntary or involuntary, under applicable bankruptcy laws.
- 13. Termination. It is the intent of the parties that this Agreement continue in effect throughout its term until occurrence of the expiration date as provided for elsewhere in the Agreement. In the event that any circumstance arises, which in good faith reasonable opinion of the City or the BCC necessitates the termination of this Agreement, then said party shall give sixty (60) days written notice to the other party and unless a different length of notice is ordered by a court of competent jurisdiction. Either party has a sixty (60) day period or the period of time allowed by a court to remediate or to take any lawful action to remedy or cure the circumstances giving rise to potential termination. In the event of termination under this paragraph, it is not the intent of the parties that the City benefit from the termination of this Agreement by taking operational control of the facility. In the event that the City may be benefited, then the parties will negotiate in good faith to reach a fair and equitable settlement of the matter; provided, however, that nothing contained herein shall be deemed to obligate the City prospectively for any financial expenditure.
- 14. Annual Review. Each year at least sixty (60) days prior to the Lease Renewal, the City and BCC shall meet and review the following:
 - (a) Maintenance issues concerning the Tower Center improvements. Discuss if each of the parties are meeting their maintenance obligation and are each of the parties

financially prepared to address any upcoming maintenance responsibilities.

- (b) Review and discuss and service delivery issues concerning exterior and ground appearance provided by the City and patron complaints about programming provided at Tower Center by the BCC.
- 15. Binding Effect. This Agreement shall be binding upon, and inure to the benefit of, the City, the BCC and their respective successors and assigns.
- 16. Amendments. This Agreement may be amended in writing at any time upon the mutual agreement of the City and the BCC. Any such amendment shall not become effective unless executed by duly authorized representatives of the City and the BCC.
- 17. Severability. If a court of competent jurisdiction determines that any provision of this Agreement is invalid or unenforceable the determination shall not invalidate or render unenforceable any other provision of this Agreement.
- 18. Notices. All notices and other communications required or permitted to be given under this Agreement shall be deemed to have been properly given if in writing and deposited in the U.S. first class mails, postage prepaid, addressed as follows:

City of Bartlesville Attn: City Manager 401 S. Johnstone Ave. Bartlesville, Oklahoma 74006

Bartlesville Community Center Trust Authority Attention: Managing Director 300 SE Adams Blvd. Bartlesville, Oklahoma 74003

The City and the BCC may, by notice given in accordance with this provision, designate a different address for notices and communications.

- 19. Applicable Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Oklahoma.
- 20. Independent Contractor. Nothing in this Agreement is intended or shall be construed as in any way creating or establishing the relationship of partners or joint ventures between the City and the BCC, or as designating the BCC as an agent or representative of the City for any purpose. In the performance of its obligations under this Agreement, the BCC is at all times acting and performing as an independent contractor, and the City does not have or exercise any control or direction over the manner and means by which the BCC performs its obligations under this Agreement, except as otherwise specifically stated within this Agreement.
- 21. Temporary Suspension of City Obligations. Anything in this Agreement to the contrary notwithstanding, if the City does not have available to it sufficient legally available funds for use in performance of its obligations under this Agreement, the City will not be obligated to perform its obligations for the fiscal period in which the City has insufficient legally available

funds. The City shall notify the BCC of such non-availability in writing at the earliest possible time. During any fiscal period in which the City's obligations are suspended pursuant to this paragraph, the BCC may (i) perform the obligations of the City at the BCC's expense, (ii) suspend its operation of Tower Center as required by this Agreement, or (iii) terminate this Agreement. The suspension of the City's obligations pursuant to this section shall only exist for the fiscal period in which the City has insufficient legally available funds.

22. Entire Agreement. This Agreement supersedes all previous understandings and agreements between the BCC and City regarding Tower Center and any other matters covered by this Agreement. This constitutes the entire understanding and agreement of the parties.

LEASE AND OPERATING AGREEMENT

This Agreement is made and entered into as of 164 day of April , 2019, by and between the City of Bartlesville, Oklahoma, a Oklahoma municipal corporation, (the "City"), and the Bartlesville Community Center Trust Authority, a public trust, (the "BCC"), for the management, maintenance, and operation of the Tower Center at Unity Square ("Tower Center") located between the Bartlesville Community Center and the Price Tower in downtown Bartlesville.

Background

- A. On March 4, 2018 Bartlesville voters approved General Obligation Bond Proposition #2 which included funding for a downtown gathering space to be known as Tower Center at Unity Square ("Tower Center").
- B. Construction of Tower Center is ongoing.
- C. The City is interested in increasing access to art and cultural activities for the community and wants to facilitate the operation of the Tower Center for the benefit of the citizens of Bartlesville.
- D. The BCC is experienced in programing performing and visual art activities and other cultural events which improve the quality of life in the community.
- E. The parties have agreed that upon completion of Tower Center, BCC will market, manage, program, and operate Tower Center for the benefit of the Bartlesville Community subject to the requirements hereinafter set forth.
- F. It is the intent of the City that the BCC share these responsibilities with the Price Tower Arts Center as may be further defined and agreed to by the parties and Price Tower Arts Center.

The parties agree as follows:

- 1. Term. Upon completion of Tower Center, a Final Site Plan will be completed and incorporated in this document as Appendix A for the purpose of describing the "Leased Premises." The Initial Lease Term of the lease of Tower Center shall be one (1) year, which shall commence on the first of the month following the date on which a Certificate of Use and Occupancy has been issued for Tower Center, subject to the requirements of Section 13 below.
- 2. Lease Renewal. This lease shall renew automatically upon the expiration of its term unless either party provides written notice to the other party of its intent not to renew the Lease at least thirty (30) days prior to expiration of the then current lease term.

3. Permitted Use; Operational Standards.

(a) General. After completion of construction and upon commencement of the lease term, the BCC shall be solely responsible for the full cost of any alterations,

improvements or additions to the Tower Center. The BCC must secure the permission of the City before performing any repairs, maintenance or improvements to the real estate or buildings of Tower Center which exceed \$25,000. For any such projects, the City will assist the BCC in contracting the work to the BCC's specifications. The BCC shall at all times comply in all material respects with all existing and future laws, rules and regulations applicable to or affecting the BCC, and its operations in Tower Center.

- (b) Fees, Charges, and Donations. The BCC will determine the eligibility of individuals, families and organizations for participation in programs at Tower Center; provided that, the BCC will ensure that its programs conducted at Tower Center are accessible to members of the community during all normal hours of operation. The BCC may impose activity fees and charges for participation in programs and activities conducted by the BCC at Tower Center. The activity fees must be priced in accordance with fees and charges typical of similar organizations in similar communities and must be consistent with the BCC's stated goals of permitting participation by individuals, families and organizations form the surrounding area. All revenues paid for use of Tower Center or donations received for Tower Center operations shall be paid to and belong to the BCC and shall be restricted for operating costs of the Tower Center. All donations received for capital improvements to Tower Center shall be paid to and belong to the City and shall be restricted for capital improvement of Tower Center.
- (c) Concessions. The BCC may grant licenses for limited portions of Tower Center to concessionaires of the BCC's choosing and otherwise subcontract limited operational functions to subcontractors of the BCC's choosing. The BCC is responsible for compliance by all concessionaires with all applicable local, state, and federals laws. Further the BCC is responsible for all actions and activities of any subcontractors with regard to Tower Center and shall bear sole responsibility for making all payments to any such subcontractors.

(d) No Discrimination.

- (i) The BCC shall not exclude any individual, group or organization from participation in, deny the benefits of, or otherwise tolerate unlawful discrimination on the basis of race, creed, color, national origin, sex, age, physical handicap or sexual orientation, in the use of Tower Center in any contracts relating to Tower Center, in any programs carried out on the premises of Tower Center, in the employment of any individuals who may provide services or work at Tower Center, or in the selection of vendors, suppliers, service providers, students, teachers, sponsors or others in matters relating to the use or operation of Tower Center.
- (ii) The BCC will require compliance with the provisions of this section by any person (including any subcontractor that provides goods, services or other items) who uses or accesses Tower Center. The BCC shall not be responsible for noncompliance with this section by any person other than the BCC.

- (iii) As between BCC members and non-members, the BCC shall furnish its accommodations and/or services on a fair, equal, and not unjustly discriminatory basis to all users thereof, and it shall charge fair, reasonable, and not unjustly discriminatory prices for each service. The BCC may make available reasonable and nondiscriminatory discounts, rebates or other similar types of price reductions. Noncompliance with this section shall constitute a material breach of this Agreement. In the event of such noncompliance, the City shall have the right to judicially enforce such provision.
- (e) Personnel. The BCC shall employ all Tower Center personnel and shall be responsible for hiring, training, promoting and discharging personnel, and for all other matters relating to personnel and staffing, including paying salaries, wages, payroll taxes, unemployment benefits and any other form of compensation or benefit to any personnel at Tower Center. The BCC's employees, agents and personnel are not employees of the City. The BCC may enter into arrangements with others relating to loaned or leased employees, but, notwithstanding the foregoing, the BCC is responsible for the conduct, behavior, appearance and attitude of all personnel at Tower Center at all times. The BCC will establish and adhere to written standards and criteria applicable to all employees, staff and service personnel of Tower Center. The employee standards and criteria will require, among other things, civil conduct, good behavior, well-kept appearance, positive attitude and helpfulness to patrons at all times.
- (f) Complaints. The BCC will consider and handle any complaints of employees, families, guests or others who use or receive any of the services or resources of Tower Center. The BCC will establish and adhere to procedures for receiving and processing complaints in an orderly and timely manner. Upon request by the City, and subject to any privacy and confidentiality obligations imposed by law, the BCC will advise the City of actions taken on a specific complaint involving Tower Center operations.
- (g) Safety. The BCC will post rules governing the conduct and behavior of any person who uses or accesses Tower Center. The BCC will hire trained and competent personnel necessary to enforce the rules of conduct. The BCC will develop and adhere to a written plan governing comprehensive safety of Tower Center. The safety plan will establish emergency procedures with regard to natural disaster, acts of violence and perceived or actual threats of violence. The BCC also will establish general safety requirements relating to security, lighting, and other appropriate safety matters.

4. Maintenance.

(a) Costs and Expenses. The BCC will pay all costs and expenses of operating Tower Center, with exceptions provided herein, and will maintain the park facility and improvements to Tower Center. The BCC shall comply with all applicable federal, state and local laws, rules, regulations, and specifications relating to the Tower Center park facility. Also, the BCC shall keep and maintain all equipment,

- furnishings, appliances and other personal property in good operating condition and in accordance with applicable manufacturer's specifications.
- (b) Repairs. The BCC will make all repairs necessary to keep Tower Center in good condition and from deteriorating in value or condition, ordinary wear and tear excepted. The BCC will commence repairs with regard to any and all aspects of Tower Center as quickly as reasonably possible, but in no event later than 60 days from the date that the need for such repairs is discovered and reported to the BCC. Such repairs will be made in expeditious and workmanlike manner. In the event that the BCC does not undertake such repairs within the time provided, or if the City determines that an emergency requires repairs to be performed immediately, the City may, after two days' written notice to the BCC, undertake to make such repairs as it may deem necessary for and on behalf of the BCC, and in such event, the BCC shall reimburse the City for the cost of such repairs upon request.
- (c) Exterior and Structural. BCC will maintain the pavilion, landscaping and parking areas and other areas of Tower Center in a good state of appearance and at BCC's expense.
- (d) Cleanliness and Sanitation. The BCC shall keep Tower Center, tidy, orderly and in good order and condition at all times and shall arrange for or oversee the prompt collection and proper disposal of trash, garbage, litter and debris.
- (e) Landscaping. BCC will maintain all landscaping at Tower Center in neat and tidy condition, and will undertake, supervise or oversee appropriate watering, fertilizing, weed removal and lawn maintenance.
- (f) Utilities. The City shall provide solid waste, water and sanitary sewer services to Tower Center free of charge to the BCC. The City shall pay for general electric use at Tower Center, provided, however, that the BCC shall make application for, obtain, pay for, and be solely responsible for all utilities required, used, or consumed at the performance stage, including, but not limited to, gas, water, telephone, electricity, and cable television.
- (g) No Waste. The BCC shall neither commit nor allow to be committed any waste at Tower Center, nor shall the BCC maintain, commit or permit the maintenance or commission of any nuisance at Tower Center or use Tower Center for any unlawful purpose.
- (h) Reserve Funds. The BCC shall maintain reserve funds sufficient in the BCC's reasonable judgment to meet the BCC's maintenance obligations under this Agreement.
- 5. Insurance. The parties shall maintain insurance with regard to Tower Center pursuant to the following terms:
 - (a) General Liability Insurance. The BCC shall maintain premises liability insurance at

the BCC's expense throughout the Initial Lease Term and any renewal insuring the City and the BCC against liability for injury to or death of any person occasioned by or arising out of the management, occupancy and operation of the Tower Center, providing not less than a \$125,000 per occurrence coverage limit and a \$1,000,000 aggregate coverage limit. The policy of insurance shall provide that the insurer must notify the City at least 30 days before cancellation or termination of the policy. Said amounts shall be increased annually as the City's exposure under the Oklahoma Governmental Tort Claims Act increases. The City shall not be required to maintain general liability insurance but agrees that it will be liable for its own negligence and willful misconduct and that of its officers, employees and authorized agents in accordance with the Oklahoma Governmental Tort Claims Act. The City and the BCC acknowledge that insurance policies do not always cover all events that create liability for an insured.

- (b) Property and Casualty Insurance. The City shall maintain property and casualty insurance with annual reimbursement by the BCC throughout the Initial Lease Term and any renewal a policy of fire, extended coverage, vandalism, malicious mischief and burglary insurance covering damage to Tower Center in the full amount of the replacement cost of Tower Center (excluding land and the footings and foundations) with deductible amounts reasonably determined by City. The insurance policy required to be maintained pursuant to this section shall name the City as the loss payee. Except as set forth below, any proceeds from said insurance shall be paid by City to the BCC to pay the cost of repairs relating to the insurance payment, except in the case of Complete Loss (see subparagraph (e) below). Said insurance shall provide a deductible consistent with deductibles under policies usually and customarily carried for similar buildings. Deductibles shall be the responsibility of the BCC.
- (c) Evidence of Insurance. The City shall furnish evidence to the BCC of insurance required by this section.
- (d) Waiver of Subrogation. All policies covering real or personal property that either party obtains affecting the Leased Premises shall include a clause or endorsement denying the insurer any rights of subrogation or recovery against the other party. The BCC and the City waive any rights of subrogation or recovery against the other for damage or loss to their respective property due to hazards covered, or that should be covered, or that are typically covered by policies of insurance obtained by either party, or that should be or have been obtained pursuant to this Lease, to the extent of the injury or loss covered by such insurance. For purposes of the preceding sentence, any deductible shall be deemed to be insurance coverage.
- (e) Complete Loss. If Tower Center is substantially damaged or destroyed by fire or any other casualty, the City shall, at its option, within 180 days from the date of the damage or destruction, begin to repair, reconstruct, or replace the damaged or destroyed building or improvement and pursue the repair, reconstruction, or replacement with reasonable diligence so as to restore the building to substantially the condition it was in before the casualty, or

- 6. Fiscal Management. The BCC may charge the public a fee for the use of Tower Center consistent with the policy of the BCC. Fees charged to users will be determined based upon the amount of revenues which the BCC needs to maintain its overall operations. In all cases, fees charged to users of Tower Center will be fair and reasonable. The financial activities of the Tower Center shall be kept separate from the financial activities of the BCC. Additionally, the financial records of the Tower Center shall be presented in a separate column in the BCC annual audited financial statements, so that the assets, liabilities, net assets, revenues, expenses, and other activities of the Tower Center can be easily viewed separate from those of the BCC. This information may be presented as supplementary information, a combining schedule, a note to the financial statements, or in any other manner that meets the minimum requirements of this section and generally accepted accounting principles. Upon request by the City, the BCC will provide reasonable access to the financial records of Tower Center, including books, records, software, work papers, financial statements and other supporting documentation
- 7. Management Committee. The BCC shall create a committee for the purpose of overseeing its obligations under this Agreement. Such committee shall consist of the following members:
 - (a) Two (2) representatives designated by the Bartlesville City Council;
 - (b) A representative designated by the Price Tower Arts Center Board of Trustees;
 - (c) A representative designated by the Bartlesville Community Center Trust Authority;
 - (d) A representative designated by the Bartlesville Convention and Visitors Bureau Board of Directors; and
 - (e) Three (3) at-large representatives designated by the five (5) aforementioned representatives of the management committee.
- 8. Taxes. The BCC shall timely pay any and all taxes, assessments, license fees, excises, and charges of every sort, nature, and kind ("Tax") that are levied, assessed, charged, or imposed upon or against Tower Center during the term of this Agreement. If the BCC considers the imposition of any Tax to be improper, illegal, or excessive, the BCC may dispute and contest the Tax. In such event and to the extent permitted by law, the BCC will not be required to pay the Tax until it is determined to be valid. The BCC must first notify the City of any Tax dispute. The City shall cooperate with the BCC at the BCC's expense in any Tax contest.
 - 9. BCC Representations. The BCC represents and warrants to the City that:
 - (a) this Agreement and all other documents referenced herein have been duly authorized and, upon execution and delivery, will constitute legal, valid and binding obligations of the BCC, *enforceable* against the BCC in accordance with the terms thereof;
 - (b) with regard to Tower Center, the BCC is in full compliance with all applicable environmental laws, rules, requirements, order, directives, ordinances and regulations, and the BCC is not aware of any potential claim or liability under any such environmental laws, rules, requirements, orders, directives, ordinances and regulations or of any events, conditions, circumstances, activities, practices, actions or plans which may give rise to any such claim or liability.

- 10. Additional Facility Use. The BCC will advise, consult and cooperate with the City and the Price Tower Arts Center to make Tower Center available from time to time to the City and the Price Tower Arts Center for city and Price Tower functions, community events and City or Price Tower sponsored activities. The City will not pay any fees associated with these occasional uses. It is the intent of the parties that the BCC share responsibility for visual arts programming at Tower Center with the Price Tower Arts Center.
- 11. Indemnification. Each party will indemnify and hold harmless the other party and its agents, officers and employees from and against any and all liabilities, losses, damages, costs and expenses (including attorney's fees, alternative dispute resolution expenses and other fees and expenses), causes of action, suits, claims, demands and judgments of any nature arising out of or in connection with any aspect of Tower Center operation or any activity that occurs in Tower Center Property, except to the extent directly caused by the negligence or willful misconduct of the either party or its agents, officers or employees acting in their official capacity as such (and not as patrons of Tower Center) to the extent provided by the law.
- 12. Events of Default. Except as otherwise set forth in this Agreement, this Agreement may be terminated only upon the occurrence of an Event of Default. It shall be an Event of Default if:
 - (a) the BCC fails, through no fault of the City, to satisfy in any material respect its obligations under this Agreement, and the failure continues for 30 days after written notice by the City;
 - (b) the BCC experiences an event or materially violates an agreement with a third party, which event or violation, in the City's reasonable judgment, will materially change the BCC's ability to perform its obligations under this Agreement;
 - (c) the BCC is subject to any action, voluntary or involuntary, under applicable bankruptcy laws.
- 13. Termination. It is the intent of the parties that this Agreement continue in effect throughout its term until occurrence of the expiration date as provided for elsewhere in the Agreement. In the event that any circumstance arises, which in good faith reasonable opinion of the City or the BCC necessitates the termination of this Agreement, then said party shall give sixty (60) days written notice to the other party and unless a different length of notice is ordered by a court of competent jurisdiction. Either party has a sixty (60) day period or the period of time allowed by a court to remediate or to take any lawful action to remedy or cure the circumstances giving rise to potential termination. In the event of termination under this paragraph, it is not the intent of the parties that the City benefit from the termination of this Agreement by taking operational control of the facility. In the event that the City may be benefited, then the parties will negotiate in good faith to reach a fair and equitable settlement of the matter; provided, however, that nothing contained herein shall be deemed to obligate the City prospectively for any financial expenditure.
- 14. Annual Review. Each year at least sixty (60) days prior to the Lease Renewal, the City and BCC shall meet and review the following:
 - (a) Maintenance issues concerning the Tower Center improvements. Discuss if each of the parties are meeting their maintenance obligation and are each of the parties

financially prepared to address any upcoming maintenance responsibilities.

- (b) Review and discuss and service delivery issues concerning exterior and ground appearance provided by the City and patron complaints about programming provided at Tower Center by the BCC.
- 15. Binding Effect. This Agreement shall be binding upon, and inure to the benefit of, the City, the BCC and their respective successors and assigns.
- 16. Amendments. This Agreement may be amended in writing at any time upon the mutual agreement of the City and the BCC. Any such amendment shall not become effective unless executed by duly authorized representatives of the City and the BCC.
- 17. Severability. If a court of competent jurisdiction determines that any provision of this Agreement is invalid or unenforceable the determination shall not invalidate or render unenforceable any other provision of this Agreement.
- 18. Notices. All notices and other communications required or permitted to be given under this Agreement shall be deemed to have been properly given if in writing and deposited in the U.S. first class mails, postage prepaid, addressed as follows:

The City and the BCC may, by notice given in accordance with this provision, designate a different address for notices and communications.

- 19. Applicable Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Oklahoma.
- 20. Independent Contractor. Nothing in this Agreement is intended or shall be construed as in any way creating or establishing the relationship of partners or joint ventures between the City and the BCC, or as designating the BCC as an agent or representative of the City for any purpose. In the performance of its obligations under this Agreement, the BCC is at all times acting and performing as an independent contractor, and the City does not have or exercise any control or direction over the manner and means by which the BCC performs its obligations under this Agreement, except as otherwise specifically stated within this Agreement.
- 21. Temporary Suspension of City Obligations. City Council Address

Good evening Mayor Copeland, City Council members, and staff.

Thank you for the opportunity of speaking to you tonight. Recently, several adult entertainment performers "danced" in the presence of minors in a public park. This event was advertised as a family-friendly event, but the performers' acts, which are typically seen in a bar or 21+ club, included removing clothing, dancing provocatively, and accepting cash tips from the audience, including children. So what is the standard for family-friendly entertainment in our public spaces? Is there a standard? Are there any contracts or permits that outline how our public spaces can be used?


I've heard arguments that since the performance was accepted by those in attendance, then it's permissible; if you don't like it, then don't go; since everyone in attendance was peaceful, then there really isn't anything the city can do - but is this truly our standard for public areas in Bartlesville? Using this reasoning, any conduct would be considered family-friendly and permissible as long as the group in attendance thinks it's okay. This is no standard at all, and not what I want for our community. We have rights in this country, and I do not deny anyone the right to live how they choose, but we should be able to agree that exposing children to sexually charged entertainment normally performed in a bar or strip club does not belong in a public space. And I have a petition with 2,000 signatures from concerned Bartlesville residents who do agree that this was inappropriate for a public park.

City Council members, I ask you to determine if this activity violated any state laws, city ordinances, or city contracts for use of public areas and if so, to take appropriate action. If no laws or ordinances were broken, and no current contracts violated, then I ask you to study this issue and consider a new city ordinance to prohibit adult-oriented activity from happening in our public areas again. Thank you.

PRACTICES AND PROCEDURES

2021

Thank you for choosing to hold your event at the Tower Center at Unity Square, hereafter referred to as Unity Square, managed by the Bartlesville Community Center, hereafter referred to as BCC. Please read this document and the signed contract carefully as all rules and regulations will be strictly enforced.

<u>Acoustics</u> The sound levels for Unity Square Stage will be limited to a maximum of 90 decibels (dB), "A" weighted, at 85 feet from the front edge of the stage at center. This level will apply to all sound systems including, but not limited to, the Unity Square sound system, rented systems, band provided systems, etc. This also applies to all FOH sound engineers, whether BCC provided, or band/rental company provided.

Sound levels will be strictly enforced by a BCC representative. These rules are in place because the stage plays into a residential area directly across the street. If sound levels are consistently above 90 dB, the BCC representative will ask that the volume be turned down. If levels continue to be above 90 dB, the Bartlesville Police Department will be called. If there continues to be a problem, the event will be shut down. Please take this seriously.

For reference, a volume of 90 dB at 85' gives you a volume of 95 dB in the middle of the seating area, and 100 dB at the front of the seating area.

Alcohol At Events If alcohol (liquor, wine or beer) is to be served or sold at a private event this must be noted on Lessee's contract with the BCC. Lessee is required to meet all the requirements of the Oklahoma ABLE (Alcoholic Beverage Laws Enforcement) Commission. Security officer/s, depending on the size and nature of the event, is/are required (hired by the Unity Square). Alcohol may only be distributed to invited guests who are 21 and older. If alcohol is to be sold, the BCC requires a copy of the liquor license, presented 72 hours prior to the event.

<u>ASCAP & BMI</u> Lessee is responsible for all fees associated with American Society of Composers, Authors and Publishers (ASCAP) and Broadcast Music, Inc. (BMI).

Box Office Organizations using the facility for ticketed performances are required to use the Bartlesville Community Center's Box Office. The Box Office will sell tickets during regular business hours and online, 24/7.

<u>Handling Fee</u> The BCC charges a small box office handling fee, per ticket. The handling fee does not apply to complimentary tickets.

Performance Content As this is a public space and open to citizens of all ages, the Lessee is responsible to ensure that movies, videos, music, and productions at Unity Square are appropriate for the audience attending the event as set out in the Motion Picture Association of America (MPAA) film rating system and local community standards. Lessee must also notify the Box Office if an event will have content which may not be appropriate for certain age groups as patrons must be advised at the Box Office at the time of ticket purchase. At the sole discretion of the Unity Square Management Committee, it may require the work to be redacted or canceled if it determines that the work violates local community standards of decency and finds that the work, taken as a whole: appeals to the prurient interest; depicts or describes, in a patently offensive way, sexual conduct specifically defined by the applicable state law; and lacks serious literary, artistic, political or scientific value.

<u>Event Promotion</u> is the sole responsibility of Lessee; however, Lessee may provide Unity Square with print ready artwork (JPEG preferred), photos and program descriptions. BCC will co-promote reserved events and use approved materials to co-promote ticketed events to the best of its ability, beginning one month prior to event date, via advertising on its Website, Marquee, Center flat screens, social media outlets and monthly e-blasts.

<u>Concessions</u> Lessee is responsible for all contracts with concession vendors. Copper Bar and Restaurant reserves the right to bid on food and beverage concessions, though Lessee has the right to choose their vendor. Lessee may opt to use more than one vendor when event serves a large audience and charge and retain event vendor fees.

<u>Conduct</u> Lessee is responsible for the conduct of all event guests, vendors, representatives, performers, volunteers, and participants during the signed contract time at Unity Square. Lessee is responsible for making certain that all persons involved are familiar with BCC/Unity Square policies. Lessee will be held liable and financially responsible for any damages of Unity Square, including public artwork.

<u>Contact Person</u> Lessee's contract requires the designation of one person from the organization as the event contact, through whom all communications with the Unity Square will flow. An alternate contact may also be designated. The BCC will only accept information and changes regarding rental from the contact person or the alternate designee as listed on contract. For events on stage, please provide contact information for technical contact person.

<u>Contracts</u> Any Lessee using contracted agencies or services, shall provide copies of those contracts to the BCC prior to the event, and receive BCC assistance. Please allow at least one month for BCC review of said contracts or cancellation of vendors by the BCC may be necessary. Providing inaccurate information regarding the Unity Square and its rules and deadlines, may prevent future use of the facility by Lessee. The BCC maintains no written or verbal agreements with any vendors.

<u>Curfew</u> By City of Bartlesville ordinance, all events on stage and any amplified sound must conclude by 10:00pm. Park closes at 11pm.

<u>Fixtures</u> Lessees must receive written permission from the BCC in order to remove or relocate park signs; trash receptacles; and/or other fixtures from their permanent placement.

<u>Holidays</u> Use of the facility on a Unity Square holiday will be double the regular rental and labor rate. Holiday Rates apply to the following days: December 31; January 1; Good Friday; Easter; Memorial Day Weekend; Independence Day; Labor Day Weekend; Thanksgiving, and the Friday following; Christmas Eve; and Christmas Day.

<u>Liability Insurance</u> All Lessees having public or ticketed events at the Unity Square must submit a liability insurance certificate verifying an active policy and naming the City of Bartlesville, Bartlesville Community Center and Price Tower Arts Center as additional insureds. Minimum requirement is \$1,000,000 bodily injury liability per occurrence. Tickets may not be placed "On Sale" until a document naming Lessee as insured is presented with all signed contracts. Event date/s may be canceled by the BCC if an insurance certificate is not received within 30 days prior, and no refunds will be made.

Manager On Duty A manager may not be on duty at all times when the Unity Square is rented. For larger events/festivals/productions designated staff members will be present. The BCC Technical Director must be on site when the outdoor stage is being used which requires specific technical assistance. For all other rental areas, a Front of House manager is available upon request. All decisions by these authorities regarding the safety of the Unity Square, its occupants and equipment, are to be followed, and can/will be enforced, if necessary, by police and fire officials.

<u>Parking</u> Unity Square and the Bartlesville Community Center are part of a multiuse facility and share the adjoining parking lot. Lessees should be aware that parking may be limited during simultaneous events at both venues. The parking lot may be rented for additional event space, car shows, bike races, etc. Performers and crews of productions must use the small parking lot behind the BCC mainstage. Parking is allowed in designated spots only. Double parking and overnight RV parking is **not allowed at any time** without written permission from the BCC Managing Director. Designated handicapped parking must be observed and illegally parked vehicles are subject to towing at the owner's expense.

<u>Pets & Service Animals</u> are welcome at Unity Square. They should be kept on a leash at all times. Visitors must pick up after their animals. Barkers and fighters (canine or human) will be asked to leave the area.

<u>Production Meetings</u> All Lessees having events on the outdoor stage or having "production" type events in other spaces on the Unity Square must have a production meeting with the BCC Technical Director. The purpose of this meeting is to discuss all technical, staffing and equipment needs for the event, as well as to establish a production schedule for multiday events. The production meeting must take place no less than 30 days prior to the start of the Lessee's rental period. Larger events and festivals may require multiple meetings. Lessee's artist's Technical Riders must be made available to the BCC Technical Director 7 days in advance of the production meeting.

Pyrotechnics The use of any type of pyrotechnics (live flame, sparklers, gerbs, flash pots, fireworks, etc.) are not allowed on the Unity Square without the written approval of the BCC Technical Director and Managing Director. A request to use pyrotechnics must be made at least one month prior to the beginning of the Lessee's rental time, and a signed letter of acknowledgement must be made between the Unity Square and the Lessee. The Unity Square in no way claims to be experts in the use of pyrotechnics, and the purpose of the signed acknowledgement is simply to make sure that both parties are aware of the use of pyrotechnics in the Lessee's performance. While not required by Oklahoma law, the BCC highly recommends the Lessee obtain approval from the Bartlesville Fire Department before using pyrotechnics on the Unity Square. Any damages to Unity Square equipment/property or injuries to persons resulting from the use of Lessee's pyrotechnics including the repair cost or replacement of said equipment/property will be the responsibility of the Lessee. The Unity Square will assume no liability in the use of Lessee's pyrotechnics will be allowed prior to the Unity Square having a current copy of the Lessee's liability insurance on file. Pyro must be listed on Lessee's certificate of insurance.

Rain Dates If a date is requested to utilize indoor facilities as a back-up location in case of rain, a non-refundable deposit for the BCC Stage, Community Hall, Studio, Balcony or Gallery or Price Tower Arts Center facilities, will be required at the time the hold is made and the contract is signed.

Rental Time There are two times listed on Lessee's contract; Rental Time and Event Time. The Rental Time is the actual time Lessee (and vendors, guests, etc.) will be allowed into the rented area(s), and the time Lessee expects to be completely out of the area. Lessee should plan their rental time carefully. Should Lessee require more than contracted time on the day of the event, Lessee may add the time if the space is available, however, it will be billed at a rate of double time. The Event Time listed on Lessee's contract is the actual time the event is planned to begin and end for Lessee's guests.

Rental Equipment & Tents Event equipment such as tents, chairs, tables, subflooring, fencing, heaters, fans, etc., may be rented from outside vendors and used at Unity Square. Tents can range in size but are required to fit on the grass areas of Unity Square. A fee, to maintain & replace grass; damaged plants; sprinkler heads and other damages which may occur during use of tents, will be charged contingent on tent size. All tents must be secured with anchor weights. No water barrels or stakes. 120v electric is available for heaters, fans, and lighting. Proper ventilation and cord covers are required.

<u>Restrooms</u> Small, indoor restrooms are provided at Unity Square on the westside of the Stage. These are open to the public and can be used by Lessee and their guests during events. For Festivals and groups larger than 200 people, arrangements can be made for access to the BCC lobby restrooms. A minimal fee will be applied to the final invoice. Portable restrooms are not permissible at Unity Square. Public restrooms may not be blocked by artists as dressing rooms.

<u>Security For Events</u> The Unity Square requires security if Lessee will be serving alcohol during event, or event is predominantly presented by or attended by children, teens or young adults (proms, teen parties, dance recitals, etc.) or otherwise requires Security. Charge for security will be noted on Lessee contract and invoiced per officer, per hour and will be arranged for by the BCC.

<u>Smoking Policy</u> The Unity Square is a smoke free facility. Smoking of any kind, including vaping, E-cigarettes, and chewing tobacco, is not permitted anywhere on the premises. The Lessee is responsible for informing its participants of this policy and enforcing it. Please refer to City Ordinance No. 3500 and the OK State Department of Health Title 63, Section 420A-426.

Stakes Lessee may not drive stakes into the ground. This includes tents, signs, horseshoes, etc.

<u>Technical</u> When Unity Square technical equipment (sound, lighting, video, etc.) is used, BCC technical department heads must be hired to operate said equipment. The first department head will be billed at the rate of \$50 per hour and the others (if needed) will be billed at the rate of \$25 per hour. All positions require a 4-hour minimum. Any additional BCC technical support (stagehands) needed will be billed at \$25 per person, per hour, with a 4-hour minimum per person. Please see **Sound**, **Lighting** and **Notes** sections for additional details.

<u>Supervision</u> The BCC Technical Director, or a representative thereof, will be on sight for all events using Unity Square technical equipment, or using BCC supplied technical labor. The Technical Director will be on sight from the time your contract starts until the load-out is complete. All activity on stage, including all personnel (crew, artist, sponsors, etc.) and the use of Unity Square equipment, will be under the supervision of the Technical Director. The Technical Director is for supervision only and is not to be considered a working hand.

<u>Sound</u> Smaller events using up to 8 channels and not using the Front of House Console, will require the BCC Sound Department Head, with sound being controlled on a tablet from on stage. This person will be on the call from the time your contract starts until the load-out is complete. Any event using the Front of House Console (required if using more than 8 channels) will be required to use an additional BCC Sound Technician (1 technician on stage, 1 for the FOH Console). Both technicians will be on the call from the time your contract starts until the load-out is complete.

Lighting Events taking place during daylight hours, or only using "work lights" will not be required to use a Lighting Technician. All events using the actual stage lighting (LED pars) will be required to use the BCC Lighting Department Head. This person will be on the call from the time your contract starts until the load-out is complete. All lighting fixtures are "pre-focused" and cannot be refocused without prior approval from the BCC Technical Director. Any fixtures refocused for your event must be returned to the standard focus during load-out, and any additional labor time required to do so will be added to your bill at the rate of \$50 per hour.

Notes Additional stagehands (sound, lighting, video, and general hands) may be hired through the BCC. Lessee is responsible for the cost of all additional stagehands, to be billed at the current hourly rate with a 4-hour minimum per call per person. Load-in (set up), show, and load-out (tear down) are all separate 4-hour calls. Any additional crew hired (beyond those listed above) are not required to work all three calls. On events where crew members are working more than 4 hours straight through without a meal break, the Lessee will be required to provide a meal for each crew member. Please consult with the BCC Technical Director before ordering food as there is always the possibility of food allergies or special considerations. The above requirements are subject to change once the BCC Technical Director has seen your Technical Rider and a production meeting has taken place. Labor on recognized BCC holidays, listed under **Holidays** in this document, are billed at double the standard rate.

Technical Equipment The Unity Square does not guarantee the worthiness or operation of its equipment, nor does the Unity Square guarantee equipment inventory numbers. Any equipment that is not in working order is considered to be out of service and is not available for Lessee's use. Inventory numbers are subject to change and should be confirmed before Lessee's load-in. The Unity Square will not assume any responsibility for shortness of equipment inventory. Equipment needs should be determined during tech meeting with Technical Director one month prior to event to make alternate plans if necessary.

Volunteer Crew All volunteers working on stage or working with technical equipment around Unity Square must wear appropriate shoes. Examples of appropriate shoes are: heavy tennis shoes, work shoes or boots. The following are not to be worn while working on stage or around technical equipment: flip flops, open toed shoes of any kind, canvas tennis shoes, any other soft style shoes. Remember, you will be working with road cases on wheels, some of which weigh several hundred pounds. These cases may cause severe damage should they roll upon someone's foot. It is the responsibility of the presenting organization to make sure all volunteer crew members are aware of this rule. The BCC Technical Director will ask anyone not wearing appropriate shoes to either change shoes or stop working around the technical equipment.
