#### **GENERAL INFORMATION:**

The proposed budget for the Bartlesville Municipal Authority is included below for your consideration and approval on Monday, June 5, 2023.

The total appropriations for the Authority as a whole are \$17,969,678. These budgeted amounts are for Construction, debt service, and to reimburse the Water and Wastewater Operating funds for operating costs.
