Dear Sir or Madam,

There is a new national opioid settlement involving Purdue Pharma L.P. (and certain affiliates) and the Sackler family. The settlement is approximately 4,553,791,480.53 for all states and territories, with Oklahoma's portion estimated to be 28,015,883.91 over ten years. These funds will be used to address the harms caused to Oklahoma's citizens from the opioid epidemic. The total amount that Oklahoma litigating political subdivisions will be eligible to receive in this national settlement with Purdue and the Sacklers depends on the participation of Oklahoma litigating and certain Oklahoma non-litigating subdivisions. Without your participation, the overall amount of the settlement will be less, and there will be less money in Oklahoma to combat the opioid epidemic.

If your political subdivision has not already received the information, it will soon receive a notice of the national settlement referencing Purdue from the National Opioid Settlements Implementation Administrator. Additionally, the designated representative of your subdivision will receive a DocuSign email from the settlement administrator (Rubris) asking for their signature on the participation forms ("Participation Forms"). The current participation deadline is **September 30, 2025**. I encourage you to participate. Please place the following language on the agenda for your next meeting and approve your participation in the Purdue/Sackler settlement:

Consideration of approval to participate in the Purdue Pharma L.P. bankruptcy case and GESA settlement, including agreeing to the terms of the Purdue bankruptcy plan and GESA settlement, the release of all claims against Purdue, the Sacklers, and certain affiliates, and the permissible uses of monies received pursuant to the settlements for opioid abatement and designation of an authorized representative to sign the subdivision participation forms to finalize participation in these settlements.

After passage and approval, please have the designated representative sign the DocuSign that was emailed to them by the settlement administrator.<sup>1</sup> Please also send a copy to any of the below, and feel free to contact them with any questions:

To be clear, this new settlement with Purdue does not affect your ability to apply for an award of \$12.5 million previously set aside through the State of Oklahoma settlement with Purdue. Under the earlier settlement, the Oklahoma Opioid Abatement Board (“Board”) will award grants to eligible political subdivisions through its established grant process at a later date.

I urge you to assist your community and the State in combating the opioid epidemic by participating in these settlements and funding programs. Again, to participate in the new settlement, you must execute, without alteration, the Participation Forms and submit them **on or before September 30, 2025**.

**A RESOLUTION TO APPROVE PARTICIPATION IN SETTLEMENTS WITH  
PURDUE PHARMA LP, MEMBERS OF THE SACKLER FAMILY, ALVOGEN,  
INC., AMNEAL PHARMACEUTICALS, INC., APOTEX, INC., HIKMA  
PHARMACEUTICALS USA, INC., INDIVIOR, INC., MYLAN  
PHARMACEUTICALS INC., SUN PHARMACEUTICAL INDUSTRIES, INC.,  
AND ZYDUS PHARMACEUTICALS**

**WHEREAS**, pharmaceutical opioids have harmed the City of Bartlesville, Oklahoma and its citizens.

**WHEREAS**, Purdue and the Sackler's have agreed to settle claims of political subdivisions in the Purdue bankruptcy plan (the "Plan") in Case Number 7:19-bk-23649, currently pending in the U.S. Bankruptcy Court for the Southern District of New York, and in the Governmental Entities Settlement Agreement ("GESA") which settlement agreement is dated June 17, 2025.

**WHEREAS**, the City of Bartlesville, Oklahoma is eligible to participate in settlement agreements presented by the generic opioid manufacturers Alvogen, Inc., Amneal Pharmaceuticals, Inc., Apotex, Inc., Hikma Pharmaceuticals USA, Inc., Indivior Inc., Mylan Pharmaceuticals Inc., Sun Pharmaceutical Industries, Inc., and Zydus Pharmaceuticals (collectively, the "Secondary Manufacturers"), which are dated April 4, 2025.

**THEREFORE**, it was duly moved and seconded that the following resolution be adopted.

**THEREFORE, BE IT RESOLVED** that the City of Bartlesville, Oklahoma hereby authorizes the Mayor, or the Mayor's designee, to execute the Purdue Settlement Participation and Release Forms ("Purdue Participation Forms") contained in the GESA settlement agreement, and agrees to the terms set forth in the Participation Forms, including release of the City of Bartlesville's claims being released in the settlement agreements with Purdue Pharma and the Sackler's.

**THEREFORE, BE IT RESOLVED** that the City of Bartlesville, Oklahoma hereby authorizes the Mayor, or the Mayor's designee, to execute each of the Settlement Participation and Release Forms ("Participation Forms") contained in the settlement agreements with Alvogen, Inc., Amneal Pharmaceuticals, Inc., Apotex, Inc., Hikma Pharmaceuticals USA, Inc., Indivior Inc., Mylan Pharmaceuticals Inc., Sun Pharmaceutical Industries,

Inc., and Zydus Pharmaceuticals (or to execute a combined Settlement Participation Form for these Secondary Manufacturers electronically), and agrees to the terms set forth in the Participation Forms, including release of the City of Bartlesville's claims being released in the settlement agreements with Alvogen, Inc., Amneal Pharmaceuticals, Inc., Apotex, Inc., Hikma Pharmaceuticals USA, Inc., Indivior Inc., Mylan Pharmaceuticals Inc., Sun Pharmaceutical Industries, Inc., and Zydus Pharmaceuticals.
