The City of Bartlesville, Oklahoma is requesting bids for the purchase of New Paint Striper. Unit shall be new, current production model. Bidder will specify year and model of Paint Striper. If no bids meet desired specifications, other similar Paint Stripers will be considered if they are deemed satisfactory to meet the needs of intended use.

Bids should be submitted on the bid form provided. **The best bid, not necessarily the lowest, as determined by the Director of Public Works for the City of Bartlesville will be accepted.** Questions regarding these specifications should be directed to: Keith Henry, Director of Public Works, regarding any questions and/or concerns about bid specifications at 918-338-4103 or kbhenry@cityofbartlesville.org.

Bidders must note any exceptions to the specifications and indicate those specific exceptions to the bid in a letter accompanying the bid at the time of the bid opening.

Bidder shall complete every space in Bidder's Proposal column. The bidder shall give a complete description of the item being bid, such as sizes, capacities, dimensions, etc.

GENERAL:

Materials shall be of good commercial quality for the intended service and shall be produced by use of current manufacturing processes. Material shall be treated to resist rust, corrosion and wear.

The design of the mechanical members shall be such that the stress imposed through normal shock loads at maximum engine torque shall not cause rupture or permanent deformation or undue wear on any member.

The bidder shall satisfy the purchasing official that they maintain a store or branch within 200 miles of the working location of the machine, staffed with qualified servicemen and with provisions for storing a representative supply of parts for the machine offered and with provisions for securing parts from the manufacturer within a reasonable length of time.

Bidders must submit with their bids the latest printed specifications and advertising literature on the units they propose to furnish

Bidder shall be prepared to give a complete demonstration of the merits of the machines offered as directed by the purchaser. The machines so demonstrated shall be complete as offered by the bidder for this bid.

The instructions shall include step-by-step use methods and include adequate illustrations, diagrams, and other applicable aids. Special attention shall be given to safety considerations for personnel and equipment.

Exploded Parts list or manual giving part descriptions and numbers shall be provided.

WARRANTY:

The equipment furnished in accordance with these specifications shall be covered by a standard manufacturer warranty on the units bid. **WARRANTY TERMS SHALL BE SUPPLIED WITH THE BID.**

The manufacturer shall warrant the equipment to be new and of quality construction free from defects in materials and workmanship. The warranty will become effective upon acceptance by the Owner or Owner's authorized agent.

The City reserves the right to reject any or all bids and to waive any formalities or technicalities in any bid received without explanation.

The City reserves the right to accept the bid which is determined to be in the best interests of the City. The equipment covered by this bid shall be F.O.B. Bartlesville, OK 74003. Any Individual equipment components shall be crated in structurally adequate containers to prevent damage during shipping, to facilitate ease of handling, and to provide suitable protection from weather. Packing containers shall be permanently labeled with appropriate equipment identification, shipping address, and return address. Packing lists shall be provided with the equipment at time of delivery.

Bidder should be able to guarantee delivery of small parts within three (3) working days and delivery on major parts within five (5) working days
